The approval of Adenosine Injection takes total sterile products approvals to 16 and Meloxicam Tablets takes total Oral products approvals to 12.

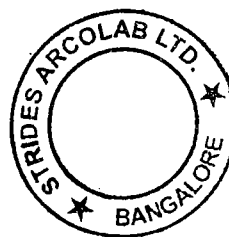
